

ASIA'S NEXT TOP MODEL CYCLE 6

ELIGIBILITY REQUIREMENTS

Please note: the following eligibility requirements and terms must be met in order to proceed with the application process for ASIA'S NEXT TOP MODEL CYCLE 6 (the "**Series**").

1. Participants who have previously applied are welcome to submit new applications for the current cycle.
2. At this time there will only be a limited number of casting calls in selected countries in Asia. **FOX Networks Group Asia Pacific Limited ("FNG")** and **Refinery Media Pte Ltd ("Production Partner")**, and together with FNG, the "**Producers**") reserve the sole right to schedule, reschedule, relocate and cancel such casting call(s), and to make any other arrangements to find and communicate with candidates, which may include, without limitation, Facebook, Instagram and Twitter, all at Producers' discretion. Aside from in-person casting calls, applications can be made via the following website: www.asntm.com.
3. If selected as a participant of the Series ("**Participant**"), a Participant must be willing to live in a house or apartment located at a location and in a city as determined by the Producers (the "**Model House**") for not more than 2 months, during April to May 2018 with not more than 14 other Participants unknown to each other, where a Participant will have no or extremely limited privacy. These dates are tentative and the Producers reserve the right to change these date at their sole discretion without notice to applicants and Participants. However, in such event, the Producers will in good faith provide at least one week's notice to Participants prior to their move-in day into the Model House.
4. If an applicant is selected as a Participant, subject to further approval by the Producers, the Producers will arrange and pay for the Participant's travelling expenses from the closest major airport to the Participant's declared residence to the production location.
5. It is a Participant's responsibility to make any necessary arrangements in anticipation of her extended absence from home, including but not limited to with the Participant's employer and family members.
6. It is intended that the Model House will have one or more filming crews present at all times equipped with video and audio recording devices which will record, broadcast and exhibit a Participant's actions and voice at all times, twenty-four hours a day, seven days a week in every room of the house as well as any and all locations and settings outside of the Model House for the duration of a Participant's participation in the Series. A Participant may be observed at all times by the Producers as well as the general public watching

the Series on various media channels, including but not limited to free and pay television and the internet.

7. While living in the Model House, each Participant will have a strict schedule of activities to follow, which the Producers may change at any time without notice. All actions and activities of a Participant will be subject to supervision by one or more members of the Series' production staff and a Participant will not be allowed to travel or leave the Model House except with the explicit permission of the Producers.
8. The winner of the Series, which will be selected by the panel of judges, will be eligible to receive the grand-prize that will include a modeling contract.

Requirements

Basic Requirements

9. Subject to the Producers' right to make an exception, all applicants must:
 - a. be female;
 - b. be at least 16 years of age and below 27 years of age at the time of submitting the application;
 - c. be at least 168cm in height;
 - d. be a national of any country in Asia or be of Asian descent;
 - e. hold a passport that is valid up to at least 31 December 2018, as regional / international travel may be required;
 - f. must be in excellent physical and mental health; and
 - g. not be a candidate running for public office or a person in public office.
10. It is preferred that applicants do not have previous experience as a model in a national advertising campaign within the last two (2) years (including, but not limited to, appearances on television and print advertisements), but the Producers reserve the right to accept any applicant with any amount of experience. The Producers reserve the right to make any exceptions.
11. Participants must agree not to become a candidate for public office until after the initial broadcast of the entire Series.
12. The Producers are looking for a dynamic group of individuals who are articulate, interesting and exhibit enthusiasm for the Series as well as a willingness to share their most private thoughts in an open forum of strangers. This group of individuals, while meeting the technical requirements of the Series, must also have sufficient physical, psychological, and mental capacity

to endure approximately two months in a monitored house under extraordinary conditions.

Represented Applicants

13. If an applicant is represented by an agent or manager and is selected to be interviewed for the Series, the applicant must provide sufficient evidence to the Producers that such representation is non-exclusive, no charges will be incurred by the Producers and nothing will prevent the applicant from (i) fully accepting any modeling contract prize or performing the obligations of such prize; and (ii) performing such obligations, talent access and appearances as may be required by the Producers and/or the Series' sponsors, the details of which shall be provided to the Participants at a later stage.
14. The Producers reserve the right to make it a condition that an applicant terminates such representation, or any part of it, before the Producers consider whether to select the applicant as a Participant.
15. The Producers further reserve the right to make it a condition that a Participant terminates such representation, or any part of it, any time during the production of the Series, including but not limited to, before selecting the winner of the Series and continuing through to the last airing of the final episode of the Series.
16. The Producers and any entity or person related to the Series shall not in any manner whatsoever be responsible or liable in connection with any termination of such representation by an agent or manager or other representative. All applicants and Participants shall solely be responsible for any consequences that may arise from the termination of such relationship.

Application and Selection Process

17. Applicants must authorize the Producers to conduct civil, criminal, financial, driver-history and any other type of background checks deemed necessary by the Producers.
18. Applicants and Participants may be required to pose and be photographed or videotaped while clothed or partially clothed.
19. Applicants who are selected for an interview must:
 - a. complete and return a Medical History Form, as provided by the Producers;
 - b. undergo physical and mental examinations conducted by medical professional(s); and
 - c. meet all physical and psychological requirements.

20. Applicants who are selected as Participants must complete a participant package provided by the Producers which will include among other things, release forms and waivers for the applicant and her immediate family members to sign.
21. Employees, officers, directors and agents of FNG, Production Partner or of any of their respective licensees, assigns, partners, parents, affiliated and subsidiary companies or the immediate family (spouse, mother, father, sister, brother, daughter or son, regardless of where they live) or members of their same households (whether related or not) of such employees, officers, directors and agents are not eligible to apply to become Participants in the Series.
22. It is intended that not more than 16 individuals would be offered the opportunity to become a Participant, and three additional “backup” offers being made.
23. The Producers reserve the right to change any of the eligibility requirements and terms, including the terms of any prizes to be awarded, at any time and without notice. If an applicant does not agree to any changes made by the Producers, the only remedy available is to withdraw from the application process and she shall not be entitled to claim any damages and/or loss of any nature from the Producers.

Application Package

24. **DEADLINE:** April 8, 2018. We urge and encourage applicants to send in their submissions as soon as possible. The Producers reserve the right to change the deadline without advance notice.
25. The full application package consists of the following:
 - a. Participant Application Form that is written legibly or typed, including an irrevocable authorization signed by the applicant;
 - b. a video that complies with the following:
 - i. Length: Maximum length is five (5) minutes. Any video over five (5) minutes will not be considered;
 - ii. Format: .AVI / .MOV / .Mp4 digital file to be uploaded as per website instructions;
 - iii. Content: Tell us who you are and why you would make the ultimate top model. Be creative! Part of your video should at least include you showing us your best runway walk.
 - c. No Music: Please do not include any music in the video;
 - d. Three photographs of yourself, in .JPG format as follows:

- i. one photograph of the close-up of an applicant's face;
 - ii. one full-length photograph of the applicant's entire (clothed) body; and
 - iii. one full-length photograph of the applicant wearing a swimsuit;
 - e. The photographs must be in full color. Please note that the Producers are looking for a variety of models including plus size models.
26. The video file and photo files must be named using the following format if they are submitted online:

[Country]_[First Name]_[Last Name][No.]

For example, if the applicant, Jane Smith was located in Indonesia, her files would be named:

27. All materials sent by an applicant (including video and photos) will be retained by the Producers. By sending such materials, an applicant agrees that such materials shall immediately become the property of the Producers and will not be returned to an applicant whether or not an applicant is selected as a Participant. Any expenses incurred by an applicant during the application process including postage, shipping and materials preparation (video, photos, etc.) are the applicant's sole responsibility. The Producers will not reimburse an applicant for these expenses. Only one application per person is allowed. All decisions of the Producers are final and absolute and not subject to inquiry or appeal.
28. Applications will only be considered if they are complete. An individual may apply in any of the following ways:
 - a. complete and print out the written portion of the application as found on the website and bring it to any of the open casting calls (if you select this option, you do not need to submit a video of yourself via the website). Please remember however, that Producers are not required to and may not have any casting calls for this Series; or
 - b. complete and submit your application online; or
 - c. complete and print out the written portion of the application as found on the website and submit this along with your video file and photo files labeled and in the formats as described in Clauses 25 and 26 above on a data DVD by mail or courier to:

31. The Producers reserve the right to not hold any interviews, or to modify the manner in which it conducts such interviews, or to not produce the Series at all.
